D&B Engineers & Architects, P.C. (D&B) recognizes that safety compliance is an integral component of the construction process and, along with delivering projects that are on time and on budget, we emphasize a goal of no injuries or lost time incidents.

Our safety personnel provide numerous services during construction projects. We review design plans for both 1926 (construction) and 1910 (general industry) compliance; develop and enforce construction management (CM) health and safety plans (HASPs) and associated job hazard analysis (JHA); and conduct toolbox talks for our field staff. Our safety professionals also review contractor HASPs for compliance with federal, state, local and OSHA regulations and assist contractors in enforcing their safety rules.

During construction, our safety professionals conduct site audits to verify compliance with all applicable HASP, local, city, state and federal regulations, make note of any deficiencies uncovered, establish timetables for corrective action by collaborating with the contractor to identify, and solve the issues encountered at the sites. This approach makes for a more productive relationship and allows the project to proceed more smoothly.

Our Environmental Health and Safety (EHS) Director is a certified OSHA trainer and ensures that all employees have the safety training required for their tasks. Training is conducted in-house to the degree possible and all external training is provided by reputable training institutions. This ensures the quality of expertise our people bring to their projects.

Should an incident occur at one of our sites, our safety staff is equipped to handle evacuations and other emergency plans, and assist with incident investigations (root cause analysis). Trends are logged so D&B can determine where the risks lie and make efforts to reduce these issues.

One of the biggest challenges in safety work is when "regulations meet reality", meaning it is easy to state a regulation, but often challenging to interpret and enforce since all sites are different and offer their own unique situations. D&B's safety personnel are knowledgeable in applicable regulations and have the expertise to work with site construction managers and construction staff to develop and implement solutions to these challenges.
