

Authorized by Title III of the Superfund Amendments and Reauthorization Act (SARA), the Emergency Planning and Community Right-to-Know Act's primary purpose is to inform communities and their citizens of the potential exposure to toxic chemicals. Sections 311 and 312 require businesses to report the locations and quantities of toxic chemicals stored on site to state and local governments on an annual basis (Tier I and Tier II forms). Section 313 requires specific manufacturing facilities to report annual releases of toxic chemicals to the environment (Form R).

As part of its overall environmental compliance services, D&B's SARA Title III compliance team works with both major industrial clients, as well as small to mid-sized manufacturing plants, to ensure that all toxic chemical inventory and release information submitted to federal, state and local governments is accurate and complete.
